Internal regulation

The park it's open to adults, young boys and girls (prior authorisation from a responsible adult) and kids (under surveillance and control of a parent or who for him).

1. People with height equal or over cm 130 pay full ticket price, accessing the yellow, light blue, orange, green, giant tyroleaner, violet, super violet, blue, black and tree climbing; children with a height between 110 cm and 130 cm pay the reduced ticket accessing the yellow, light blue, orange, tree climbing, tree house and tree board; children over 2 years old and less than 110 cm in height can access to the baby park exclusively equipped with a helmet, with a further reduced ticket.
2. The access to the park's structures is consenting just to all them that are equipped with regular ticket.
3. The cost of the admission ticket includes the use of personal safety and protection devices (DPI), the teaching of progression and safety techniques, of supervision by the staff in charge.
4. Each customer **progresses independently and under his own responsibility. The parent or the adult manager who signed this release is obliged to supervise minors during the duration of the games and the progression on the route.**
5. The games require a good psychophysical preparation, they are not recommended for people with diseases that limit these abilities, to pregnant women, and forbidden to those under the influence of alcohol drugs or other things that limit their abilities.
6. I'm the only and best judge of my physical conditions to participate in the activity, I am aware of the additional risks to which I expose myself voluntarily and with full knowledge. I'm in good physical and mental condition and I do not suffer from any handicap or physical conditions such as to create a danger to the use of the games. This also applies to any other members over 18 or under 18 participating in the routes listed below and for which I sign this release.
7. I accept to participate at the games and as result of this, **the adventure park Villa Basilica srl and all the organizers are free from any responsibility** in case of an accident caused by my negligence and failure to comply with the safety regulations or by accident caused to third parties for the loss or breaking of personal effects or more generally for other reasons. This also applies to any other members over 18 or under 18 participating in the routes listed below and for which I sign this release.
8. It is forbidden to access the routes in the absence of staff.
9. Before accessing the games **it's mandatory** to attend the educational briefing, (use of technical progression and safety DPI) regardless of the level of knowledge of each user.
10. The evolution of the game is mandatory for everyone. The staff reserves right to discourage or prohibit access to persons not considered suitable.
11. It is obligatory, every time you get on a game, you **always stay attached to the life line cable.**
12. It is forbidden the use of personal equipment not supplied by the park.
13. All customers are required to comply with the instructions listed here: on each atelier can access at a time just one person, on each platform can stay just two persons, it is forbidden to shake voluntarily the games, it is forbidden to throw down objects and other things from the high of the games. It is forbidden to stop or pass under the games. Only one person at the time may traverse the atelier; if when arriving at the platform and the next game is already engaged, the user must wait their turn and wait until the atelier is free. If the atelier consist of tyroleaners, the user, before attaching the pulley to the cable and launching of, must ensure that there are no other users on the tyroleaner and that the arrival area is clear.
14. The use of sportswear is recommended. Leave objects that can fall to the ground.
15. Each person who behaves in a dangerous way putting himself and others at risk will be removed from the park
16. If for several reasons it will not be possible to access the games the cost of the ticket will not be refunded.
17. By signing this application, you acknowledge that you have read and accept the Adventure Park regulations in their entirety, which can be viewed in the space provided inside the Park
