PRIVACY POLICY

Michela Antonini Architect ("us", "we", or "our") operates the <http://www.studioantoninisantini.it> website (the "Service").

This page informs you of our policies regarding the collection, use, and disclosure of personal data when you use our Service and the choices you have associated with that data. Our Privacy Policy is designed to aid compliance with GDPR or General Data Protection Regulation 2016/679. We use your data to provide and improve the Service. By using the Service, you agree to the collection and use of information in accordance with this policy.

POLICY KEY DEFINITIONS

- Service

Service is <http://www.studioantoninisantini.it> website operated by Michela Antonini Architect.

- Personal Data

Personal Data is any information that relates to an identified or identifiable living individual. We may collect your personal data when you request information about Antonini Santini Studio or any of our services.

- Usage Data

Usage Data is any Data that is collected or produced in connection with the use of the Services (for instance the visit duration).

- Cookies

Cookies are small files stored on a user's computer or device

INFORMATION COLLECTION AND USE

We collect several different types of information for various purposes to provide and improve our Service to you.

TYPES OF DATA COLLECTED

PERSONAL DATA

While using our Service, we may ask you to provide us with certain personally identifiable information that can be used to contact or identify you ("Personal Data"). Personally identifiable information may include, but is not limited to:

- Email address
- First name and last name
- Address, State, Province, ZIP/Postal code, City
- Cookies and Usage Data

USAGE DATA

We may also collect information how the Service is accessed and used ("Usage Data"). This Usage Data may include information such as your computer's Internet Protocol address (e.g. IP address), browser type, browser version, the pages of our Service that you visit, the time and date of your visit, the time spent on those pages, unique device identifiers and other diagnostic data.

TRACKING AND COOKIES DATA

We use cookies and similar tracking technologies to track the activity on our Service and hold certain information.

Cookies are files with small amount of data which may include an anonymous unique identifier. Cookies are sent to your browser from a website and stored on your device. Tracking technologies also used are beacons, tags, and scripts to collect and track information and to improve and analyze our Service.

You can instruct your browser to refuse all cookies or to indicate when a cookie is being sent. However, if you do not accept cookies, you may not be able to use some portions of our Service.

Examples of Cookies we use:

- Session Cookies . We use Session Cookies to operate our Service.
- Preference Cookies. We use Preference Cookies to remember your preferences and various settings.
- Security Cookies. We use Security Cookies for security purposes.

YOUR INDIVIDUAL RIGHTS

You can exercise at any time your rights pursuant to articles 15-22 of Regulation EU 2016/679:

- a) right to obtain the confirmation as to whether or not personal data concerning you are being processed and where access to them;
- b) right to obtain the information about the source of the personal data, the purposes and the modes of the processing, the logic involved in cases of automated decision-making, the identification details of the data controller, the categories of personal data concerned, the recipients or categories of recipient to whom the personal data have been or will be disclosed, and, where possible, the envisaged period for which the personal data will be stored;
- c) right to obtain the rectification of inaccurate personal data and to have incomplete personal data completed;
- d) right to obtain the erasure, transformation in anonymous form or block of the data in case of illegitimate treatment, including the personal data that are no longer necessary in relation to the purposes for which they were collected or otherwise processed;

- e) right to obligate the controller to communicate any rectification or erasure or transformation or block of personal data in accordance with c) and d) to each recipient to whom the personal data have been disclosed, unless this proves impossible or involves disproportionate effort;
- f) right to restriction of processing;
- g) right to data portability. This means that you have the right to receive your personal data provided to the controller, in a structured, commonly used and machine-readable format and the right to transmit those data to another controller without any hindrances;
- h) right to object, for legitimate reasons, at any time to processing of personal data concerning you, although they are necessary in relation to the purposes for which they were collected;
- i) right to object at any time to processing of personal data concerning you for direct marketing purposes;
- j) right not to be subject to a decision based solely on automated processing, including profiling;
- k) right to request from the controller rectification or erasure of personal data or restriction of processing of personal data concerning you or to object to such processing;
- l) right to withdraw consent at any time, without affecting the lawfulness of processing based on consent before its withdrawal;
- m) right to lodge a complaint with a supervisory authority pursuant to the article 77 GDPR if you consider that the processing of personal data is contrary to existing legislation;
- n) right to object, on grounds relating to your particular situation, at any time to processing of personal data concerning you pursuant to article 21 GDPR. The controller shall no longer process the personal data unless the controller demonstrates compelling legitimate grounds for the processing which override the interests, rights and freedoms of the data subject or for the establishment, exercise or defence of legal claims;
